Clinical Coding Audit

Independent audit of coded clinical data will measure and demonstrate compliance with national clinical coding standards, verify that previous audit recommendations have been actioned, support the validation of trust income relating to clinical activity and make recommendations in order to achieve quality improvements.

Information Governance (IG) Toolkit Requirements 505 (acute) and 514 (mental health) specifies that an audit of clinical coding, based on national standards, has been undertaken by a Clinical Classifications Service (CCS) approved clinical coding auditor within the last 12 months, in accordance with Health and Social Care Information Centre (HSCIC) CCS Clinical Coding Audit Methodology 2016-17 V10.0

In addition to meeting IG Toolkit requirements using EasyAudit and HSCIC CCS Clinical Coding Audit Methodology coded clinical data can be used to identify coding errors and quantify those discrepancies by calculating the impact on HRG, ensuring that appropriate reimbursement for activity is being received.

A data extraction workshop examines the various sources of documentation and reviews the information that must be collected for coding purposes.

The National Clinical Coding Qualification (NCCQ) is a nationally recognised qualification for clinical coders working in the NHS. The qualification seeks to support high quality, accurate and consistently coded clinical data, and provides recognition of the clinical coding profession. Achieving ACC status requires a high level of commitment and study. Attendance at workshops specifically designed to support coders to achieve accreditation is a fundamental part of the process. Our workshop provides an opportunity to sit a mock paper under examination conditions to identify any areas of weakness that can be used to by the learner to effectively direct the remainder of their study.

Report writing is an essential skill for clinical coders wishing to embark on achieving approved clinical coding auditor status. Report writing for clinical coding audit workshops provide aspiring auditors with the skills to write effective reports.
